One of the most significant examples is the flagship project in Egypt, where CESI has been appointed as Technical Advisor by the Egyptian Electricity Holding Company to support the modernization of power distribution grids. The agreement, signed by Pierluigi Vicini (General Manager of CESI FZE) and Abdulaziz Al-Muhaiza (Executive Vice President & CFO of PDC), underscores a shared commitment to advancing energy infrastructure, enhancing project efficiency, deploying advanced technological solutions and promoting environmental sustainability in line with Saudi Arabia's Vision 2030 energy transition goals. This MoU reinforces CESI's long-term presence in the Kingdom and its role as a trusted partner in modernizing power systems across the region
